I, the undersigned, being a clerk of the U. S. District Court of Western District of Louisiana, do hereby certify that the above named petitioner, FRIEDRICH KAHN, was on November 13, 1944

in the Court having found that there existing at 116 Odum Street, Bastrop, Louisiana, evidence to make permanently in the United States (by then recognized by the Nationalistic laws of the United States) the same all other respects complied with the applicable provisions of such naturalization laws, and was prohibited to be admitted to citizenship, thereupon and that such person and his was admitted as a citizen of the United States of America.

In testimony whereof the seal of the court is hereunto affixed this 13th day of November in the year of our Lord nineteen hundred and Forty-four and of our Independence the one hundred and Sixty-eighth.




