To file such petition it will be necessary for you to make application, in person or by letter, to the nearest clerk of court exercising naturalization jurisdiction, or to a representative of the Immigration and Naturalization Service, for an application Form A-2214. You should not delay doing this until near the close of the 7-year period, because if you do not file your petition with the court prior to the expiration of this 7-year period it will be necessary for you to file a new declaration of intention and wait at least another 2 years thereafter before you can file your petition for naturalization. If you should marry a citizen of the United States, a declaration of intention is not required as a basis for filing your petition for naturalization.
