An absence from the United States of 1 year or more during such periods will break the continuity of your residence for naturalization purposes, except that after you have resided in the United States for at least 1 year and have filed a declaration of intention, if your absence abroad is made necessary because you are an employee of the United States Government, an American institution of research, or an American firm or corporation engaged in foreign trade and commerce of the United States, you may prevent a break in the continuity of your residence for naturalization purposes by making an application on Form N-470. For complete information you should address the office of this Service nearest to you, or the "Commissioner of Immigration, and Naturalization, Washington, D. C."

Nationality and Race.—Nationality in statement No. 6, page 3, refers to the country of which you are a citizen or subject. 




