(Domestic Relations Law, Section 14)

Where either or both of the parties is under the age of twenty-one years, the marriage shall be solemnized only by a clergy-man, mayor of a city, justice or judge of a court of record, justice of the court of Special Sessions of the City of New York, justice of the Domestic Relations Court of the City of New York or by a judge of a Children's Court. (Subdivision 5, of Section 11 of the Domestic Relations Law)
